PRESIDENT'S **By Paul McCormick** MESSAGE

Volunteers Make Glendale Vibrant

It's already February and it seems like Christmas and New Year's were just here. The rinks and skating oval are going strong. Turtle Hill as always has some of the best tobogganing around. If you get a chance, take a walk on a Saturday or Sunday afternoon, it's pretty magical to watch all the happy faces from babies to grandparents enjoying our community gathering places that make Glendale/Glendale Meadows a special place.

I'm not sure if everyone knows how many volunteer hours go into maintaining our facilities and programs, but suffice to say it's a lot — at least hundreds, maybe thousands of hours. I have to say thank you to all those volunteers who keep coming out and doing such an incredible job.

Special thanks to our board volunteers who set the direction for the things we do in Glendale. Operating a community association is something our board does on behalf of all 1,100 households in Glendale. We keep the hall maintained and in tip-top shape for the Glendale Community Preschool, for youth programs such as Guides and Scouts, for groups looking to rent the hall for social functions and business meetings. Not only does it take volunteers to build this vibrant centre, it takes money and planning.

In January, board members gathered at the hall for a business planning session facilitated by Hayley Saunders, our community liaison from the City of Calgary. We developed drafts of a mission and vision statement and set priorities and plans in place to make sure we do everything we can to keep our facilities in good repair with enough money to fund our operations. We will publish our plans and priorities in the Thumper as they are finalized.

It is expensive to cover the costs of utilities, maintenance and insurance. Our insurance alone is over \$6,000 a year.

And there are limited sources for funding our operations. Our major source of revenue is Alberta Lottery funds generated by Glendale volunteers who work at a casino. This year's casino takes place March 21-22 when we need more than 40 volunteers. If you've never been on one of our crews, now's the time to sign up. You'll have a great time for a great cause. And I can't stress how important this event is.

Our \$35 membership fee is another key source of revenue, but we need stronger participation from every household in Glendale. Less than 20 per cent of households typically buy their annual community membership. Just \$35 a year is not much to ask homeowners living in our great community. We have a membership drive coming up and we'll let you in on plans for a great prize one lucky community member will receive.

Whether you use the community facilities or not, they add to the value of every property in Glendale. If we let our facilities get run down or don't maintain them it could be a different story.

We will be running several social functions throughout the year, including our first awesome Winter Bash on January 30, Glendale Community Preschool Snow Day on February 6, our summer Stampede Breakfast and Sports Day in September. They aren't big money makers, but they are awesome community builders. Make sure you come out to meet your neighbours and eniov everything Glendale has to offer.

Next time you are walking your dog, dropping your kids at school, Scouts or Guides, lacing up your skates, tobogganing, playing ball, or just driving through Glendale, slow down and take a closer look at what really makes our community the best little town in the big city. You do.

"Volunteering is the ultimate exercise in democracy. You vote in elections once a year, but when you volunteer, you vote every day about the kind of community you want to live in.





Winter in Calgary is unlike anywhere else in Canada. Bitter cold and blowing snow can be followed up the next day with chinook winds melting it all away. Even with those chinook winds, sometimes winter can get to us.


I find one of the best ways to kick the wintertime blues is to get out in the community and take advantage of some of the snowy weather recreational activities that this city has to offer.

While I like taking advantage of the mountains close by for skiing, with so many community skating rinks scattered throughout Calgary Currie, you don't need to go far to enjoy the benefits of living in such a great place as Calgary.

February is the Heart and Stroke foundation's Heart month. It is important to remember to stay physically active for both our bodies and our minds. The Heart and Stroke Foundation recommends that adults do at least 150 minutes of moderate to vigorous physical activity per week, in bouts of 10 minutes or more. The activity doesn't have to be non-stop, nor does it need to be strenuous. You can do 10 minutes or more at a time throughout the day to reach your daily total. A brisk 10 minute walk during lunch, playing for 10 minutes with your kids after work, and then another 15 minutes walking your dog in the evening. Five minutes here and there add up to better health.

If you're like me and sometimes like a bit more excitement, there is little that exemplifies the Canadian spirit more than a game of pickup shinny at the outdoor community rink where coming together for community recreation has no need for formal organization. All it takes is people coming together to have fun.

I love the sense of community these rinks bring to our city, and despite my busy schedule with my work at the Legislature in Edmonton, I spend as much time as I can at these meeting places at the heart of our communities. You may have seen me out there over the past couple months warming people up with coffee and hot chocolate, and if you keep your eyes open, you might catch me out there again before the end of skating season.



2016 Property Tax Assessment

It is that time of year again. As the Ward 6 Office often receives your inquires around property taxes this time of year, I wanted to share with you some helpful information regarding your property tax assessment. The 2016 assessment notices were mailed on January 5, 2016 and your 2016 assessment information is available on www. calgary.ca/assessmentsearch. The customer review period runs until March 7, 2016. Until this date, property and business owners are able to inquire about their assessment value if they have any questions or concerns. If you have any questions or would like to make changes to your assessed value, please do so by March 7, 2016. You can also visit www.calgary.ca/propertytax for important dates, bill and account information, as well as payment information.

Other reminders to note:

• Property taxes are due June 30, 2016. A 7% late payment penalty will be applied to any unpaid portion of property taxes on July 1 and October 1. Further penalties of 1% will be added the first day of each month to any portion remaining unpaid after December 31, 2016.

• The deadline does not apply to property owners who pay monthly through The City's Tax Installment Payment Plan (TIPP). More than 240,000 property owners pay their taxes monthly through TIPP. Property owners can join TIPP at any time by visiting the Web site at www.calgary.ca/TIPP to request an application or calling 311.

• Help is available to assist eligible low-income homeowners who meet income guidelines and eligibility criteria, regardless of age. The 2016 Property Tax Assistance program will accept applications to the program starting on June 1. For more information or to download an application form, go to www.calgary.ca/ fairentry.

• The Alberta Seniors Property Tax Deferral program allows eligible senior homeowners to defer all or part of their property taxes through a low-interest home equity loan with the Alberta government. Please visit www.seniors.alberta.ca/seniors/property-tax-deferral. html for details and application form.

October 19th, the political landscape changed in Canada but in Calgary Signal Hill the residents elected to endorse the Conservative Party of Canada and myself.

First, I want to express my thanks and gratitude for the support of confidence that I received. I would like to thank the hundreds of volunteers who worked on our campaign and those who donated personally in so many ways. I also want to express my thanks and good wishes to the other candidates from the riding who sought election especially, Kerry Cundal of the Liberal party, Khalis Ahmed of the New Democrats and Taryn Knorren for the Green party. Being a candidate in a general election requires a lot of hard work, time and money, especially in a campaign as long as this one. Each of the other candidates should be thanked for ensuring voters had a choice in our democratic process.

In the aftermath of a long election campaign, combined with the Christmas holiday period, the House of Commons only met for seven days in early December, resuming the spring session in late January. Our interim leader Rona Ambrose has appointed me as a member of the House of Commons Standing Finance Committee which has oversight over Government spending and holds consultations with Canadians regarding the federal budget. As the only Member of Parliament from the three western most provinces on the committee I consider it a huge honour to be one of 10 persons charged with overseeing government spending. I will have more to report on the work of the committee in future accounting to constituents. I also had an opportunity on the first day of Opposition replies to the throne speech to make my maiden speech in the House. It was a special privilege to speak about the Battalion Park initiative and express my concerns that energy, agriculture or forestry, the wealth generators in this country, weren't mentioned in the throne speech. 2016 is going to be a very difficult year in Alberta. Commodity prices will remain weak, unemployment rates are expected to rise along with federal and provincial taxes. My responsibility as your representative will be to listen to constituents who have real issues and assist where possible. Not a snowbird? Try fair weather skiing on Waxless cross country skis!

A great way to enjoy Alberta's sunshine and long winters is to be outdoors! If you don't like the cold and don't want to fuss with waxes, waxless skis are a great alternative. They work the best in temperatures of -6 to + 3 degrees C. On warm Chinook days, or for spring skiing, they are perfect! You don't have to learn to apply the day to day sticky wax on the base of your ski, but waxless skis do require glide wax on the tips and tails as well as the scales. This protects your ski base and ensures you glide across the snow!



Haven't been out skiing for a while? There are many places to take a cross country ski lesson. It is a great way to get back to skiing or, to start out on the right foot for the first time! No line ups, no crowds, no lift fees, cross country skiing is a great way to enjoy the sun, fresh air and gentle exercise. What could be better than a day outside with friends skiing in West Bragg Creek, Ribbon Creek or other parts of Kananaskis country! There are two websites for checking trail conditions; Skierbob and on the Alberta Parks website. There are groomed and track-set ski trails as far west as Banff National Park and as far east as Shaganappi golf course, when we have enough snow in Calgary. I think of cross country skiing as a cross between trail biking and walking, it is smooth and heavenly, with a little good technique. So get out of the city and get signed up for safe, gentle outdoor fun!
