



69th Ave (J. Lee) - DP2016-0095 (M-C1 ~90 units): Committee met architect to review preliminary designs. This significant redevelopment broadly affects nearby residents so an open house will be held in the fall. Rezone release is pending DP approval.

840 68 Av DP2016-0484: M-CG (4 units): DP is released.

55 Kirby Place - DP2016-2667 (R-C1): Committee reviewed an application for a front porch addition. Committee had no objection and viewed this project as an enhancement to the streetscape.

Hi Kingsland Residents: Over the past few weeks some people on 5th Street have been experiencing sewer backup in their basements. Please see comments from City to our Community Board when we posed this problem late last year. If you cannot or do not wish to have a backflow preventer installed you might want to call 311 and get on the list of houses to be contacted when work is being done in the back lane of 5th and 7th Street.

"Water Services indicates that the 5 Street / 7 Street area is where a flat line is – old infrastructure that requires regular maintenance every 5-8 months.



Dear Constituents:

As we transition to autumn, I hope all of you were able to make the most of summer and get ready for the new school year and upcoming ventures. It was a great time for myself to do a selfreflection and I want to ask yourselves about the best possible ways I can best serve you as your MLA. I would be delighted to learn about how I can be the best I can be as the MLA representing you. Therefore, please contact me at the contact information provided to share your thoughts and suggestions. I look forward to having your feedback.

I, your MLA along with the government have been working very hard to create jobs in Alberta and boost our province's economy. The collapse in oil prices has caused economic pain and anxiety throughout the province. For this reason, in this newsletter I would like to share information about the Alberta Jobs Plan in-depth.

Alberta Investor Tax Credit: \$90 Million for the new Alberta Investor Tax Credit provides a credit to those investing in smalland-medium sized enterprises.

Capital Investment Tax Credit: \$75 Million for this credit provides credits for the first-time acquisition of new or used property or spending in value-added agriculture, tourism infrastructure, culture, manufacturing and processing industries.

The Entrepreneurship Incubator Program: It helps entrepreneurs and small and medium sized businesses bring their ideas to market.

Reduction in the Small Business Income Tax Rate: The income tax rate for small businesses have been reduced from three percent to two percent and is effective January 1, 2017.

The New Alberta Child Benefit and Enhancements to the Alberta Family Employment Tax Credit: This provides approximately \$340 Million in combined benefits to 199,000 families and will help children get a good start in life. Also, it helps Albertans in need get back on their feet and under this plan, 380,000 children will be better off.

The Climate Leadership Plan: Invests in public transit, energy efficiency, new cleaner electricity and continuous strong negotiations with provincial and federal partners to build new pipelines-The safest and most efficient way to deliver Alberta's traditional energy products to new markets.

The Alberta Jobs Plan also provides help for apprentices to complete their training/work experience requirements and supports the Training for Work Program. For further details on the

KINGSLAND MEETING MINUTES JUNE 23, 2016

Draft, to be approved at September 8th 2016 Meeting.

Present: Chris Kemp-Jackson, Ken Reimer, Josh, Sue Barnfield, Cris Dombroski, Suzanne Bourbonnais, Ann Clarke, late arrival James Ullyott

Absent: Meghan Muhl

Guest: Maggie Dycke NPC, Brandy Kapell – Brian Pincott's office Meeting called to order: 7.05p.m.

Minutes of May 26th approved in motion by Sue, Seconded by Ken - Carried.

President's report: Chris: Short discussion on Canada 150 Grant application, Ann brought up question of whether it was advisable to spend \$137,993.00 on replacing our boarded rink in view of the fact that not many community people use the rink. We have to commit to putting in 50% of this amount from community monies. Ken felt that the rink was used sufficiently to warrant spending the money and the majority of the board agreed. Ann brought up the cost of making ice (approx. \$12,000.00 per year) in another year when Ken has put in his 3 years of free icemaking that will be an ongoing cost for the next 20 years. Ken confirmed that the rink as it stands at the moment is in such bad shape that in another couple of years it will be unsafe to play on, each year we have to put something in the region of \$2,000.00 just to replace boards.

The money for our 50% will have to come from cashing a GIC. It was felt that our 50% of the money would come from Casino but it was pointed out that we need all our Casino money to run the hall. Our year end is June 2016 and there is approximately \$12,000.00 left in our Casino budget from the current Casino revenue which could be used, this money has to be used within 2 years. We will get the money from our latest Casino in the next few weeks.

Part of our 50% will come from volunteer time and will be used to decrease the demolition budget to about \$3,000.00 and therefore reduce the cost from our portion of the 50%. Approximately \$15,000 has been accrued from the ice work Ken has been doing over the last 2 years, he volunteered to look after the ice at no cost so long as a portion of the money saved went towards replacing the rink. \$15,000.00 will be the amount that would be accrued by 2017 the date the rink will be built. The two amounts of cash will come to \$25,000.00 and the volunteer hours to build the rink would reduce it by a further \$20.000.00. Ken felt that our portion of the 50% would be somewhere in the region of \$25,000.00 cash rather than \$65,000.00.

Question asked if we could generate revenue from the new rink? To do that we would have pay someone to be at the hall every evening and weekends to look after the rink. Could we not do it on an honour system? We have a notice on the rink saying that the rink can be rented. No-one has ever phoned and asked to rent the rink, they just come and play on it because there is no-one there to collect money.

Maggie mentioned that we could also apply for the CCG grant from the City which, if approved, would pay for 75% of the cost. Ann pointed out that we have never received two grants for the same project and it was not guaranteed that we would get

this grant. We have applied for it in the past and were turned down resulting in the community having to foot the whole bill for the pre-school upgrade. Maggie felt that as the rink was in our Lifecycle "to do" list we would stand a better chance of getting the grant. This grant would be applied for at a later date. Maggie stated that the Rink has to be completed by March 20th 2018 with money from the Canada 150 grant.

Straw poll of the Board members present showed that the majority of those present were in favour of going ahead with the rink and paying 50% of the cost. Ann abstained from the vote. It was decided to wait until James came to make a formal mo-

Discussion on grant application postponed until James arrives at 8.30p.m.

Brandy Kappell - Councillor Pincott's office: No report, Councillor Pincott's office is busy with Property Taxes etc. Here to answer questions.

Question - What date does the community have to have our recycling bin installed and where do we get the bin? Bin has to be installed by November 2016, we could contract for an outside company to rent the bin and have it emptied periodically or we could rent a bin from the City. Size of the bin varies and we have to decide what size we need etc., size and collection schedule will affect price. Ann to look into this and come back to September meeting with some prices and options. Contact Enmax, 311 for City quote and private company. Pre-school Meeting:

Attended Pre-school monthly meeting and presented Board's suggestion that we do not increase the rent as the utilities have not increased significantly since the school has been in place prices have risen but use is not significantly more so we can assume increased price is due to increased utility price and not school use. Board voted at 26th May meeting to allow the school to continue paying \$900.00 per 10 month year for the rest of the 5 year contract.

However, since the school is using the meeting room the Board suggested that the school take over the cleaning duties for the whole basement. The exception to that would be if the community rented the meeting room out for an evening function and then we would have our cleaner clean the meeting room and the bathrooms.

The school are looking into the cost of hiring a cleaner to undertake the full cleaning of the basement but feel that this would be much more expensive for them than to pay the additional \$90 per month rent.

They are approaching our new cleaner to see how much she would charge them to clean the basement under a separate contract.

I RECEIVED AN EMAIL FROM THE SCHOOL ON MONDAY 20TH JUNE STATING THAT THEY CANNOT AFFORD THE \$4,750.00 PER YEAR THAT IT WOULD COST THEM TO PAY FOR A CLEANER 5 HOURS PER WEEK. WHAT DO THE BOARD WANT TO DO.

I met with our cleaner on Wednesday and she says that she would be able to clean the school room (dry mop, empty garbage, dry mop meeting room and clean the bathrooms) and she estimates it would take her 2 hours per week for 3 times cleaning. She charges \$25.00 per hour so her charge for the basement will be \$50.00 per week for 10 months. MOTION by Ken: We have our cleaner clean the basement 3 times a week as agreed to in the Pre-school Contract. Suzanne Seconded: Carried

Other items of discussion: Pre-school are concerned about the problem of homeless people sleeping and using the basement entrance as a bathroom

The school suggested and asked permission to paint the area in a brighter colour and put up murals on the walls and door to try and discourage use of this area by homeless people, it was also suggested that a sign be put up indicating Kingsland Community Pre-school Entrance which might further discourage this use. (The school would undertake to do both these things. I said I did not think we would have any objection to this plan. Agreed

If neither of these plans work we might have to look at sealing off the area completely with chain link fence and a gate but that would be for down the road.

The school also asked that their floor be cleaned professionally at the same time as the rest of the floors are being cleaned as they have been in the building 3 years and the floor has never had a real professional clean. In view of the fact that remedial work is going to be undertaken at the beginning of July in the school room (part of Lifecyle program and ordered by the City) where drywall and ceilings are going to be removed and replaced I recommend that this request should be fulfilled in order to have a clean start for September.

The cost of this additional space cleaned by KBM will be \$548 plus GST to scrub/seal and wax with 4 coats of wax. Cost of having the room cleaned after the renovations, dust from drywall etc., on stationary articles in room, Kylin will do it for \$25.00 per hour. No idea of number of hours. Another summer has come and gone. I hope you enjoyed all it had to offer in and around our city. The City of Calgary and our Community Associations held many great events to get out moving and socializing like the Canada Day celebrations in the downtown, Stampede breakfasts, festivals, and mobile skateparks.

Council is back in session after the August break, along with all Councillor appointments to special committees. I'm involved in many facets of City and partner functions, and I love these opportunities to work with great organizations and make positive changes. Here's a bit about what I have been and will be up to. I sit on two Standing Policy Committees: on Community and Protective Services, and on Transportation and Transit. I also serve on Audit Committee and the Intergovernmental Affairs Committee.

I am on the board of Attainable Homes Calgary Corporation (AHCC), Calgary Housing Company (CHC), and the Calgary Homeless Foundation (CHF). These three committees represent the continuum of ensuring Calgary's citizens are able to address their housing needs. By helping to create strategies to get Calgarians into homes, stay sheltered if they face physical or financial hurdles, and move out of the system and into home ownership, I am able to recommend policy proposals which make sense within the larger picture.

My work on the boards of Family and Community Support Services Association of Alberta (FCSSAA), and the Federation of Canadian Municipalities (FCM) allows me to guide municipal policy development in conjunction with initiatives at the federal and provincial levels, and vice versa. FCSSAA meetings take me up to Edmonton once a month and FCM meetings take me all over Canada every few months to meet with colleagues in other Ca-

nadian municipalities. With FCM, I am the Chair of the Executive Committee, on the Governance Committee, part of the Prairies and Territories Regional Caucus, on the Standing Committee on Environmental Issues and Sustainable Development, the Chair of the network of francophone municipalities, the Standing Committee on Increasing Women's Participation in Municipal Government, Chair of the Standing Committee on Social-Economic Development, on the National Municipal Energy Infrastructure Task Force and the Governance Representative for Haiti projects.

The City of Calgary is the sole shareholder of ENMAX (while the City "owns all the chips", it doesn't play them). In my role on the ENMAX Board of Directors, I am really excited about the future possibilities of electrical distribution. ENMAX is a separate legal organization, and pays the City of Calgary dividends when able. I prefer that the City use these dividends for re-investment, such as into the ENMAX Legacy Parks Fund. This is the funding mechanism behind the Sandy Beach/River Park rehabilitation project.

I also act in an advisory capacity to the BiodiverCity Advisory Committee, the Climate Change Action Advisory and the National Zero Waste Council. Healthy native flora and fauna populations give our city increased resilience in the face of climate change. Especially at the municipal level, it's important to address waste, and the real cost of waste to both the municipality and our environment.

I also serve on the Calgary Arts Development Authority board. Besides my past involvement in and love of the arts community, there is a real economic argument for the arts that we as a City need to support.


